1. This Provisional affiliation is presently for one year only for the academic session 2021-22.
2. This Provisional affiliation is based upon the notification of Health Department, Government of Bihar vide Memo No. 1-Pa.Me.-02/2020-826(1), dated 31-12-2021.
3. This provisional affiliation is subjected to your attending to all the deficiencies pointed out by the inspection team in its report dated 29-01-2022 (attached) within a period of 30 days from the date of issue of this letter.
4. Further you have to inform the university through affidavit that you have removed all the deficiencies as intimated to you vide "3" above, failing which the provisional affiliation, accorded through this letter may be withdrawn.
5. On receipt of the affidavit, as mentioned at vide "4" above, the university may send a surprise inspection team to your institution. In that case the provisional affiliation shall be deemed valid only after the satisfactory report of the surprise inspection.
6. This provisional affiliation is subject to the condition of submission of required fee as mentioned in University letter no. 006/Affili/032/AKU/2014 - 2067, dated 16.05.2017 (attached) and Endowment fee of ₹250000/- (Two Lakh Fifty Thousand only) per course through Fixed Deposit (FD) as per direction mentioned in University letter no. 004/Fin/038/AKU/2017- 1323, dated 18.05.2020 (attached), which must be deposited within a week from the date of receipt of this





- letter, failing which this letter will be automatically treated as withdrawn. In such a case no further correspondence shall be entertained.
7. Rules/regulations, etc. regarding syllabus, conduct of examinations etc. shall be communicated after all the conditions for provisional affiliation are met by your institute to the full satisfaction of the University.
 8. The University may inspect your college at any working day without information to check the infrastructure of your college as per guidelines of GoB/AKU.
 9. All minutes of Governing Body should be submitted to office of Aryabhatta Knowledge University, Patna at the earliest.
 10. When any vacant post will be filled by the college/institute, University representative should be invited. Any appointments must be done in presence of University representative.
 11. College is requested to submit the residential address proof, Aadhaar card along with mobile number of all teaching & non-teaching employee.
 12. College is requested to approve all teaching & Non-teaching employees as per guidelines of the University in three months.
 13. This provisional affiliation is granted in anticipation of approval of the Court, Aryabhatta Knowledge University, Patna.
 14. This provisional affiliation shall not take effect unless it is approved by the State Government.
 15. If any documents and statement will be found forged/fabricated in any stage, the affiliation letter will be withdrawn.
 16. Failing the above terms & conditions, this letter will be automatically treated as withdrawn. In such case no further correspondence shall be entertained.
